Board Activities

Applied for IMO NGO status - presentation went well, but were refused. There was too much similarities and overlap with other organizations. They also felt the IASST did not fully

understand how the IMO works. They will accept an application again in two years. One issue was Taiwan member of IASST. The company was asked to cancel their membership, but have full ability to attend events as special invitee, but not voting abilities. If we are not re-applying, they want to be re-instated as full member. Discussion on this item and how to move forward. The member in question was not happy about being removed, but are still willing to have membership re-instated.

NGO status requires activity from members, not just the board. The request to apply came from the membership with IMO. If members wish to re-apply, the member in question cannot be re-instated. Noted that it was only one member who needed to be removed. If we want to re-apply the membership needs to make the decision.

Suggested that IASST members who are also IMO members attend IMO events and promote IASST. New board to undertake discussion on participation, payments, etc. and defer to next meeting.

IASST web-page updated to make more user friendly. Additional tools added to improve communications as articles are added. Added abilities to hold meetings/roundtables remotely.

Future meetings -

Autumn meeting – planned host has refused. Samantha Montes has offered to host. Henk to reach out to Samantha to confirm hosting.
